# Columbia Track Club 5K Nut Race Reactor Park Feb. 3, 1990

Plenty of nuts showed up to run and race walk, 41 hearty souls who dismissed the 38 degree misty weather as a minor impediment to their pursuit of the edible. Those of us timing observed excellent running by all and some outstanding race walking by Gayle Johnson. Milene Mittelhauser served notice that she is in racing form again by turning in an outstanding 18:47 to win the women's 30-39 division and capture first female overall with Jane Downing, coming off an injury, second. Her husband, Jeff, was all alone in winning overall with a 16:54, followed by the amazing Tom LaFontaine who was second overall and first 40-49 in 17:35, Randy Smith outdueled Roger Turnbough for third place overall and Ben Londeree had an outstanding race, winning the 50-59 division and finishing 5th overall in 18:27. Ben brought along Darlene who nailed 3rd in the 50-59 group but he almost got nailed by Alan Barkema, a guest of Ben and Darlene's, who finished right behind Ben in 18:33 after matching him stride-for-stride for most of the race. Tom Allen gave blood a couple of weeks before the race but managed to hold off Dick Madsen for second in the always tough 40-49. Joe Cragin ran an excellent 31:21 to finish second behind Don Johnson with an astonishing 22:05 in the 60-69 division. Joe not only had to contend with Johnson but had to fight for his time. It seems that Hessler, the head timer, had confused Cragin with George Mummert, 21 years his junior. It was not that Mummert looked 60 but that Cragin looked 40. Nancy Fritsch turned in another great performance (25:45) to win the 50-59 and Georgina Gonzalez finished second in 27:12. Darlene Londeree was third all the while pulling Boots Gerhardt to victory in the 60-69 with an awesome 30:24 for both runners. Nine women under 25 minutes.

#### Our Marathon Lives!

I could tell Bill Clark was upset. His letter said in capital letters, "DON'T LET THE MARATHON DIE!"

I had no more than put Bill's letter into the frig to cool off, when Joyce Schulte called.

"Who's idea was it to kill the marathon?" she asked.

She sounded threatening.

"Well...I...ah..." I answered bravely.

After she finally hung up, I did some more checking. Several other CTC folks were determined to keep the Heart of America tradition going. After all, as H of A founder Bill Clark pointed out, our marathon is the fifth oldest marathon in the country. Only Boston, Yonkers (NY), Culver City (CA) and Pike's Peak are older, and I'm not sure all of those are still going.

But there will be some changes. Shelter Insurance has dropped their sponsorship. They have given a great deal of support over the years, and have expressed concern over safety.

We will move the event back to Labor Day and move the starting time back to 6 a.m. Clark says he will patrol the course during the race to help insure safety of runners. We'll try to enlist the help of Columbia Police and the Sheriff's department.

We will reserve the right to remove from the course any runners who suffer from heat stress or are in anyway endangering themselves or others.

We'll give T-shirts to all finishers and present Open, Masters and Seniors awards (male and female) plus the Dave Schulte Award for Improved Performance. We are raising the entry fee to \$10, because CTC will be footing more of the bill.

We will get insurance through The Athletic Congress, and we will remind participants at every opporunity to "be careful out there!"

Joe Duncan has agreed to be race director with staunch support from Clark, Schulte and yours truly.

There is no marathon like the Heart of America. It's scenic. It's challenging. And it's ours!
